Importantly, D&IR work is relevant to all we do, not just work explicitly labeled "diversity." I've been active in STP since 2016, engaging in roles across membership, programming, resources, and diversity, thus I have broad experience across the organization and am well-suited to serve as VP D&IR.

Beyond STP, my service has focused on making psychology a more welcoming place: on the grassroots departmental DEI committee formed in 2020, with talks/workshops on inclusive teaching, through resources developed to support instructors in fostering inclusion and equity in their classrooms. I also bring relevant scholarly expertise, i.e., a social psychology degree and 10+ years' experience teaching gender, sexuality, relationships, and race.

As VP D&IR, I will build on recent efforts, including the Statement on Addressing Systemic Racism and Inequity in STP and the 2021 Presidential Taskforce on the Integration of DEI and International Initiatives across STP (on which I served), and continue the process of DEI self-assessments across areas; ensure support for D&IR is infused throughout the organization; and include many axes of identity in diversity-related work, including social class, disability, and neurodiversity, all with the goal of helping STP be "home" to all who find us.
